Overview Kryder Gallery (www.krydergallery.com - Dahlonega, GA) is calling for entries for a contemporary photography show, "Love vs. Fear," presented in conjunction with the Atlanta Celebrates Photography Festival.</p> <p>2. Theme Facing people, beliefs or events outside what we know and feel comfortable with, do we too quickly turn to hatred, war and other attacks grounded in anger? What if anger, hatred and even war are tip-of-the-iceberg expressions when, below, we feel afraid, alone, not respected, devalued or unheard? "Love vs. Fear" is a juried show of photographs exploring the space where love and fear meet – both within ourselves and in our relationships as well as on the many stages where we act out our lives.</p> <p>4. Awards The following cash prizes will be awarded during the opening reception Oct 4: 1st place - \$500, 2nd place - \$250, 3rd place - \$100.</p> <p>5. Eligibility The show is open to U.S. photographers 18 years of age and older interested in submitting original work in all photographic media. Photos will be reviewed and selected for the show based on their alignment with the theme, "Love vs. Fear." Selections will be based solely on the juror's discretion.</p> <p>6. Checks or money orders should be payable to "Kryder Gallery" and included in the entry package.</p>	<p>8. Entry process Mailed entries will be accepted until Aug 27. Entrant permission to use images By signing the entry form, entrants agree that images can be used to promote and illustrate the Love vs. Fear show on the Kryder Gallery website, on mailed postcards, or in press releases to print media. Photographers whose work is accepted into the show will receive postcards they can use to send to their client and contact lists.</p> <p>11. Works accepted into the show Photographers will be notified of juror results on Sep 8 via the stamped, self-addressed envelope they include in their entry packages. It is preferable that work be delivered to the gallery in person. If shipped, include a</p>	<p>check or money order to cover shipping costs and insurance to return your work at the end of the show. Works must be delivered or, if shipped, arrive at the gallery no later than 5 pm, Friday, Sep 19.</p> <p>12. Framed works Works accepted into the show should be framed using white mats and include wire for hanging. Entrants who choose to ship their framed works should consider use of plexiglas to prevent breakage during shipment to and from the show. Simple black frames (metal or wood) are preferred so that viewer focus will be on the photographs themselves. Clip frames, matted-only and unframed works will not be accepted.</p> <p>13. Insurance Kryder Gallery will exercise professional conduct in receiving, hanging and returning artwork. However, Kryder Gallery is not responsible for accidental damage to or loss of accepted works, and entrants are responsible for insuring works.</p> <p>14. Gallery contract All works accepted into the show must be available for the length of the show and available for sale. Photographers whose works are accepted into the show are required to sign a gallery contract that specifies a commission structure of 60% of the sale price to the photographer and 40% of the sale to the gallery. If you are currently represented by a gallery with geographical exclusivity, please confirm with your gallery that your work can be displayed in the show at Kryder Gallery.</p> <p>15.
